	INTERVENOR-DEFENDANT THE DEMOCRATIC NATIONAL COMMITTEE'S MOTION TO DISMISS

Intervenor-Defendant the Democratic National Committee ("DNC"), by and through counsel, and pursuant to Rule 12(b)(1) of the North Carolina Rules of Civil Procedure, moves to dismiss this action in its entirety for lack of subject matter jurisdiction. In the alternative, pursuant to Rule 12(c) of the North Carolina Rules of Civil Procedure, the DNC moves for judgment on the pleadings on the same grounds. In support of the motion, the DNC respectfully shows the Court the following: 1. Plaintiffs commenced this action on September 12, 2024, seeking declaratory and injunctive relief that the North Carolina State Board of Elections exceeded its authority under N.C. Gen. Stat. §§ 163-166.16, 163-166.17, and 163-166.18 by approving the University of North Carolina at Chapel Hill's student and employee digital identification cards for use as photo identification in the 2024 general election. Plaintiffs alleged that allowing such digital cards to be used in the election would dilute the votes of their members in the 2024 general election. Plaintiffs also moved for a temporary restraining order, which was denied by the trial court on September 20, 2024.

2. Plaintiffs subsequently petitioned the North Carolina Court of Appeals for a writ of supersedeas on September 20, 2024. On September 27, 2024, the North Carolina Court of Appeals granted Plaintiffs' petition, enjoining the State Board from "accepting the University of North Carolina - Chapel Hill Mobile One Card, or any other 'image of a photo ID, either as a photocopy or a photo on a mobile device' that is prohibited by the State Board of Election's Numbered Memo 2023-03, for the purpose of casting a ballot in the November 2024 general election."

3. The Court of Appeals' order remained in effect until January 9, 2025, when the Court granted Plaintiffs' consent motion to dismiss their appeal.

4. All student and employee photo identification previously approved by the State Board for voting in the last election cycle expired on December 31, 2024, including the digital UNC ID at issue in this case. N.C. Gen. Stat. §§ 163-166.17(b), 163-166.18(b).

5. The North Carolina State Board of Elections has not approved any student or employee digital identification cards for use in the 2025-2026 elections. The list of student and employee identification cards currently approved by the North of Carolina State Board Elections is publicly available at https://www.ncsbe.gov/voting/voter-id/student-and-public-employee-ids-approvedvoting. A true and correct copy of "2025 Voter Application Approvals.csv", downloaded from the North Carolina State Board of Elections website, also is attached hereto as Exhibit A.

6. Plaintiffs have not alleged that any state or local governments have sought the State Board's approval of a digital student or employee identification card for use in the 2025-2026 elections. Plaintiffs have not alleged that the State Board intends to approve a digital student or employee identification card for use the 2025-2026 elections. For all these reasons, the case is most and the Court lacks subject matter jurisdiction.

WHEREFORE, Intervenor-Defendant the Democratic National Committee respectfully requests the Court grant its motion and dismiss this action in its entirety pursuant to Rule 12(b)(1) for lack of subject matter jurisdiction. In the alternative, Intervenor-Defendant the Democratic National Committee requests enter judgment on the pleadings pursuant to Rule 12(c) for lack of subject matter jurisdiction.
