Petitioners, Pro Se, respond to petition to intervene and avers as follows:

Response to Petition

1. [Admitted]. The results of the Secure Build validation became available late September, 2024
2. [Denied] The Democratic County Democratic Committee (DCDC) lacks standing to intervene. The Jurisdiction is the Government entity that is responsible for the Election, not the DCDC. The Jurisdiction is the Government entity that is responsible for the Integrity of The Electronic Voting System, not the DCDC.

8. [Denied] The Jurisdiction cannot and does not defend itself, the Injunction should be granted for Petitioners. Motion to Intervene should be denied.
