REQUEST FOR CLARIFICATION

Defendants respectfully seek clarification of the Court’s October 30, 2024 Order for Special and Preliminary Injunction with regard to the location and hours during which the Bucks County Board of Elections shall provide persons who wish to apply for, receive, vote, and return a mail-in ballot (On-Demand Voting).

First, Defendants request that the Court’s order be clarified to reflect that this service will be provided at the Board of Elections’ Doylestown location. Segregation of the ballots submitted during this extended on-demand voting period is required to ensure accurate poll books at each voting precinct. Ballots segregated during the election are stored securely at the Doylestown location. Additionally, Board of Elections staff have determined that they will be able to move the printers from the other two government services centers to Doylestown in order to service voters more efficiently with multiple printers at one location.

Second, Defendants request that the Court clarify that On-Demand Voting will only be available from 8:00 a.m. until 5:00 p.m. each day from October 30, 2024 – November 1, 2024 pursuant to 25 P.S. 3146.5.

PROPOSED ORDER

AND NOW, this 30th day of October 2024, upon consideration of the Petition for an Emergency Special and Preliminary Injunction of Plaintiffs, Verified Complaint, and Supporting Memorandum of Law and after a hearing held on October 30, 2024, the Court hereby **ORDERED AND DECREED** as follows:

- a) Defendants’ actions in turning away voters who sought to apply for a mail-in ballot and receive one in person before the deadline of 5:00 p.m. on October 29, 2024, violated the Election Code.
- b) Defendants shall permit any persons who wishes to apply for, receive, vote, and return a mail-in ballot (“On-Demand Vote”) to appear at the Board of Elections Doylestown Office at 55 E. Court Street, Doylestown, PA 18901. The Bucks County Board of Elections shall make available On-Demand Voting between the hours of 8:00 a.m. and 5:00 p.m. from today until November 1, 2024.
