AMENDED COMPLAINT

Plaintiffs Disability Rights Montana and Big Sky 55+ hereby amend their complaint as a matter of course pursuant to Federal Rule of Civil Procedure 15(a)(1). The Amended Complaint, which eliminates Plaintiffs' federal claims, was filed today and is lodged on the docket. Pls.' Am. Compl., ECF No. 8.

Rule 15(a)(1) permits a plaintiff to amend as a matter of course no later than 21 days after service of a responsive pleading or Rule 12 motion. Plaintiff filed its original complaint in state court on May 23, 2025 and served it upon Defendants on May 28. Defendants removed the case to this Court on June 27, and filed an Answer on July 7. Doc. 6. Plaintiffs filed their Amended Complaint on July 15. ECF No. 8.
