JOINT STIPULATION OF FACTS AND EXHIBITS

The Parties stipulate to the admission of the following facts and exhibits. By stipulating to these facts and exhibits, the Parties do not concede that such facts and exhibits are relevant or necessary for the Court to resolve this matter. The Parties have agreed not to object to the entry of these facts and exhibits into the record, reserving objections to relevance only. Matters contained in exhibits but not expressly discussed in a stipulation are part of the record and may be cited by the Parties.

1. Merrie Suzanne Luther is a Missouri citizen, resident of Cole County, a taxpayer, and qualified voter in the State of Missouri.

2. Luther is a resident of Congressional District 3 under the 2022 congressional district map and will be a resident of Congressional District 5 under the congressional district map enacted by House Bill 1 (2025).

3. Kim Randolph Davis is a Missouri citizen, resident of Jackson County, a taxpayer, and qualified voter in the State of Missouri.

4. Davis is a resident of Congressional District 5 under the 2022 congressional district map and will be a resident of Congressional District 4 under the congressional district map enacted by House Bill 1 (2025).

5. Rebeca Amezcua is a Missouri citizen, resident of Jackson County, a taxpayer, and qualified voter in the State of Missouri.

6. Amezcua is a resident of Congressional District 5 under the 2022 congressional district map and will be a resident of Congressional District 4 under the congressional district map enacted by House Bill 1 (2025).

7. Kenneth Lawrence Chumbley is a Missouri citizen, resident of Greene County, a taxpayer, and qualified voter in the State of Missouri.

8. Chumbley is a resident of Congressional District 7 under the 2022 congressional district map and will be a resident of Congressional District 7 under the congressional district map enacted by House Bill 1 (2025).

9. Denny Hoskins is the Missouri Secretary of State and is responsible for implementing the map enacted by House Bill 1.

10. The Missouri General Assembly truly agreed and finally passed House Bill 1 (2025) on September 12, 2025.

11. House Bill 1 is attached hereto as **Exhibit A**.

12. On September 28, 2025, Governor Mike Kehoe signed House Bill 1 (2025).

13. Every ten years, the United States Census Bureau conducts a census to determine the relevant population for federal congressional apportionment.

14. In 2020, the United States Census Bureau conducted the decennial census.

15. On August 12, 2021, the United States Census Bureau certified the census data to the Governor of Missouri.

16. Thereafter, the General Assembly drew congressional districts based on the 2020 census and passed such districts in House Bill 2909 (2022).

17. House Bill 2909 (2022) is attached hereto as **Exhibit B.**

18. The United States Census Bureau has not conducted a census since the 2020 census.

19. No census has been certified to the Governor of Missouri since the certification of the 2020 census occurred on August 12, 2021.
