**RESPONSE OF RESPONDENTS KANSAS CITY BOARD OF ELECTION COMMISSIONERS; SARAH (SALLY) MILLER, SHARON TURNER BUIE, AND RALPH F. MUNYAN II, IN THEIR OFFICIAL CAPACITIES AS COMMISSIONERS; AND SHAWN KIEFFER AND LAURI EALOM, IN THEIR OFFICIAL CAPACITIES AS DIRECTORS, TO APPELLANTS’ MOTION TO EXPEDITE APPELLATE PROCEEDINGS AND CONSOLIDATE APPEALS**

Respondents Kansas City Board of Election Commissioners; Sarah (Sally) Miller, Sharon Turner Buie, and Ralph F. Munyan II, in their official capacities as Commissioners; and Shawn Kieffer and Lauri Ealom, in their official capacities as Directors (collectively, “KCEB Respondents”), submit this Response to Appellants’ Motion to Expedite Appellate Proceedings and Consolidate Appeals.

1. The KCEB Respondents constitute the local election authority for that portion of the City of Kansas City, Missouri, within Jackson County, Missouri.

2. In the Circuit Court, the KCEB Respondents took no position on whether the 2025 Congressional Map violates any provision of Article III, § 45 of the Missouri Constitution.

3. Likewise, the KCEB Respondents will take no position on the merits of this appeal.

4. The KCEB Respondents will take no position on whether this appeal should be expedited or consolidated with *Wise, et al. v. State of Missouri, et al.*, Case No. SC101572.

5. The KCEB Respondents do not intend to file any briefs and do not intend to participate in oral argument.

6. The KCEB Respondents file this Response solely to inform the Court of their procedural stance.

WHEREFORE, the KCEB Respondents respectfully request that the Court take note of their position and grant such other relief as the Court deems appropriate.
