**CONSENT ORDER OF DISMISSAL**

The parties in the above captioned matter, by and through their undersigned counsel, agree to the dismissal of this action, including all claims and counterclaims with prejudice.

WHEREAS, Plaintiff initiated this action seeking declaratory and injunctive relief relating to the South Carolina Statewide Voter Registration List and the potential transfer of voter registration information or data to the United States Department of Justice.

WHEREAS, Defendants represented to this Court that it would not transfer any of the voter registration information or data that is the subject of this lawsuit to United States Department of Justice during the pendency of this lawsuit unless there is a fully executed memorandum of understanding executed pursuant to S.C. Code Ann. § 7-5-186, between the United States Department of Justice and the South Carolina Election Commission, and that Defendants would provide notice and a copy of the Memorandum of Understanding prior to any transfer.

WHEREAS, the United States Department of Justice and the South Carolina Election Commission entered into a Memorandum of Understanding signed on April 28, 2026, rendering the remaining issues raised herein moot.

IT IS THEREFORE ORDERED that this action is hereby dismissed with prejudice.
