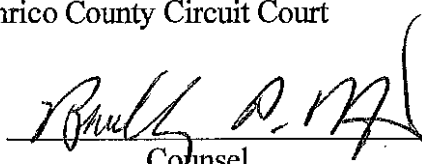
MOTION FOR NONSUIT
