IT IS HEREBY STIPULATED AND AGREED, by the parties, and Intervenor-Respondents Representative Malliotakis and Individual Voters Edward L. Lai, Joel Medina, Solomon B. Reeves, Angela Sisto, and Faith Togba (together, the “Intervenor-Respondents”), through their undersigned counsel, that the word limits for the parties’ and Intervenor-Respondents’ briefs shall be enlarged as set forth in this stipulation and order.

AND IT IS FURTHER STIPULATED AND AGREED, that the word limit for the parties' and Intervenor-Respondents' briefs shall be set as follows:

1. Petitioners' memorandum of law in support of the Petition shall be limited to 11,000 words.
2. Respondents' and Intervenor-Respondents' respective combined opposition memorandum of law and motions directed to the Petition, including motions to dismiss or for judgment, if any, shall be limited to 14,000 words.
3. Petitioners' combined reply in support of the petition and opposition to any motions by Respondents and Intervenor-Respondents directed to the Petition shall be limited to 15,000 words.
4. Respondents' and Intervenor-Respondents' respective replies in support of any motions directed to the Petition shall be limited to 11,000 words.
