**FIRST AMENDED EMERGENCY MOTION FOR TEMPORARY
RESTRAINING ORDER AND INJUNCTIVE RELIEF**

AND NOW, comes Plaintiffs, by and through their attorneys, Dillon McCandless King Coulter & Graham, LLP, per Thomas W. King, III, Esquire, and Thomas E. Breth, Esquire, to file the within First Amended Emergency Motion for Temporary Restraining Order and Injunctive Relief, and respectfully request that

this Court grant the within Motion for the reasons set forth in Plaintiffs' First Amended Complaint for Writ of Mandamus and Request for an Emergency Temporary Restraining Order and Injunctive Relief which is incorporated herein by reference as if fully set forth.

On December 3, 2020, Mike Kelly, U.S. Congressman, et al., filed an Emergency Application for Writ of Injunction pending the filing and disposition of a Petition for Writ of Certiorari with the United States Supreme Court. *Case 20A98 U.S. Supreme Court*. In the *Mike Kelly* case, Respondents are the Commonwealth of Pennsylvania, Pennsylvania General Assembly, Thomas W. Wolf, Governor of the Commonwealth, and, Kathy Boockvar, Secretary of the Commonwealth. The issues before the Court are whether the Elections and Electors Clauses of the U.S. Constitution permit Pennsylvania to violate its Constitution's restrictions when enacting legislation related to the conduct of Federal elections; and, whether the First and Fourteenth Amendments to the U.S. Constitution permit the dismissal of *Mike Kelly, et al.*, claims with prejudice based upon laches.

On December 6, 2020, Justice Alito entered an updated Order that requires the Respondents in the *Mike Kelly* case to file their Response to the Application by 9:00 a.m., Tuesday, December 8, 2020. It is not clear what, if any, action Justice Alito or the Court may take in the *Mike Kelly* case; however, if the Court grants Petitioners' request for Injunctive Relief, it will have a direct impact upon the relief

sought in the within Emergency Motion and the First Amended Emergency Motion for Temporary Restraining Order and Injunctive Relief filed herewith.
